Merchant shall provide HSBC with prior written notice of the suspension as soon as reasonably practicable, stating the reason for such suspension and the anticipated duration thereof. Any such suspension shall be without prejudice to offers already validly availed of by HSBC customers prior to the effective date of suspension, unless performance thereof is rendered impossible by the force majeure event.
