

## HSBC and Automatic Centre/Electroworld Promo Terms & Conditions:

- 5. The Freebie will be released along with the product that the customer has ordered upon delivery if via online or pick-up if in-store.
- 6. Cardholders must settle payment with their HSBC credit card to enjoy the offer.
- 7. Splitting of credit card transactions to avail of the offer is not allowed.
- 8. For each Cardholder, only one (1) card number, one (1) minimum single-receipt 0% installment transaction, one (1) Freebie redemption per day per branch for in-store, online and other digital sales channels transactions is allowed.
- 9. The offer cannot be used in conjunction with any other discounts, promotions and discounted items, unless specified.
- 10. The offer is non-transferable.
- 11. In cases of cancellation of credit card transaction, the customer should pay the price of the Freebie (PHP998).
