

Lucky Winners, Loyal Shoppers at Ayala Malls Promo

Promo Mechanics

PARTICIPATING MALLS AND PROMO DURATION

- 1. The promo is open to all shoppers of the following 14 Ayala Malls:
 - a. Alabang Town Center
 - b. Ayala Malls Circuit
 - c. Ayala Malls Cloverleaf
 - d. Ayala Malls Feliz
 - e. Ayala Malls Manila Bay
 - f. Ayala Malls Solenad
 - g. Ayala Malls The 30th
 - h. Ayala Malls Vertis North
 - i. Glorietta
 - i. Greenbelt
 - k. Marquee Mall
 - Market Market
 - m. TriNoma
 - n. UP Town Center
- 2. The promo is from November 29, 2019 to January 31, 2020.

HOW TO JOIN

- 3. Receipts paid with a prepaid, debit, or credit Mastercard entitle the shopper to the following ways of winning:
 - a. Lucky Winners Raffle Promo: The shopper is entitled to one (1) electronic raffle coupon for every P3,000 single receipt paid with a debit, credit, or prepaid MasterCard.
 - b. Loyal Shoppers Top Spender Contest: The shopper must submit receipts paid with a prepaid, credit, or debit MasterCard. The shopper competes to achieve the highest accumulated amount which will be determined by the end of the promo. Receipt(s) must be registered under one name and one mall only.
- 4. To qualify their receipts, shoppers must register at the concierge and completely fill-out the customer information stub with following details: First Name, Middle Name, Last Name, Date of Birth, Email Address, Address, and Contact Number. Shoppers will submit the stub to the concierge for encoding to the raffle system.
- 5. A confirmation email about the promo entry will be sent to the shopper's email address.
- 6. Only receipts issued from November 29, 2019 to January 31, 2020 are eligible. Defaced, crumpled, tampered or receipts that are less than 34 its actual size will not be honored.
- 7. Refer to Annex A for a list of stores that are not included in this promo.
- 8. There is no limit to the number of raffle entries that a participant may earn as long as the corresponding purchase is made. A participant earns a valid raffle entry only upon confirmation of the purchase transaction.
- 9. Cancellation of ticket purchases results in cancellation of the equivalent raffle entries earned.

PRIZES AND TECHNICAL INFORMATION

- 10. The prizes for this campaign are as follows:
 - a. Lucky Winners Raffle Promo:
 - i. One winner per mall will receive Php 100,000 in cash.
 - ii. One winner across all participating malls will win one BMW X1 xDrive20d xLine.

- iii. Prizes will be awarded randomly via electronic raffle draw.
- b. Loyal Shoppers Top Spender Contest:
 - i. One winner per mall will win a 3 days/2 nights Deluxe Room package in Lagen Island, El Nido Resort, El Nido for 2 persons, inclusive of airfare via Airswift, full board and airport transfers. This will be awarded to the winner who accumulates the highest amount in prepaid, debit, or credit Mastercard receipts in the participating mall within the purchase period.
 - ii. Shoppers who hit Php 50,000 in Mastercard receipts immediately receive gift vouchers from El Nido Resorts vouchers granting them a 25% discount (based on Best Available Rate). They may redeem this voucher at the Avala Malls concierge.
 - iii. Prizes will be awarded based on accumulated Mastercard receipts.
- 11. Should one individual win multiple prizes, they will only be awarded the prize with the highest value.
- 12. Cut-off for earning raffle entries before the draw is on January 31, 2020 at 9:00pm.

NOTIFICATION OF WINNERS AND CLAIMING OF PRIZES

- 13. Raffle draw will be done on February 12, 2020.
- 14. Announcement of winners will be done on or before February 26, 2020.
- 15. Winners will be notified by email, telephone call and registered mail.
- 16. Winners may claim their prizes at the Administration Office of each Ayala Mall.
- 17. The prizes are subject to the following conditions:
 - a. For all prizes:
 - i. All prizes are transferable but not convertible to cash.
 - ii. The winners shall shoulder the 20% tax for prizes exceeding P10,000.00 and other expenses that will be incurred in relation to the prize.
 - iii. Prizes not claimed after sixty (60) days from receipt of notification will be forfeited in favor of Ayala Malls, with prior approval of DTI.
 - b. For car prize only:
 - i. The car prize is exclusive of the costs of delivery, first year registration, and transfer of ownership.
 - c. For trip prize only:
 - i. Prizes shall be issued in the form of a gift certificate.
 - ii. All travel certificates shall be valid for 1 year from announcements of winners.
