

Terms & Conditions

- For every Php3,000 single-receipt straight or Php5,000 installment transaction from The SM Store paid using Philippine issued credit, debit, or prepaid card entitles a cardholder to one (1) electronic raffle entry and a chance to win 125,000 PAL Mabuhay Miles.
