6. Payments for take-out, banquet sales, private functions, parties are excluded from the promo.
7. Splitting of a single transaction for the purpose of availing multiple discounts is prohibited.
8. The Promo may not be availed in conjunction with other ongoing Promos at The Pantry, Dusit Thani Manila. Senior Citizens and PWDs may either avail of this promotional discount or they may avail of the standard discount from the regular rate under Republic Act No. 7432 and 7277, both as amended under R.A. 9994.
9. The discount is not convertible to cash or any item in the menu.

The Pantry, Dusit Thani Manila reserves the right to refuse redemption of the discount by the Cardholder if the Cardholder does not adhere to the promo mechanics.
