

HSBC Credit Card's Christmas Collect Promo Mechanics

- HSBC Credit Card's Christmas Collect Promo (the "Promo") will run from November 4, 2019 to February 15, 2020.
- 2. Promo is open to all Primary and Supplementary Credit Cardholders of HSBC Classic and Gold Visa/Mastercard, HSBC Red Mastercard, HSBC Platinum Visa, HSBC Advance Visa, and HSBC Premier Mastercard locally issued by HSBC Philippines (hereinafter referred to as "Cardholders"). HSBC Corporate Cards and HSBC Debit Cards are not qualified to join the Promo.
- 3. Cardholders are entitled to get up to PHP12,000 worth of e-Gift Certificates ("eGC/s") within the promo period by earning stamps via HSBC Christmas Promo game site (the "Site"). To qualify for the promo, Cardholders must spend a minimum single-receipt straight transaction of PHP3,000 (equivalent to 1 stamp) or a minimum of PHP5,000 (equivalent to 3 stamps) single-receipt installment purchase anywhere.

Rewards:

- Giftaway eGC worth PHP500
- Giftaway eGC worth PHP1,000
- Ayala Cinema eGC worth PHP500

Every 10th stamp earns Cardholders one (1) reward. Cardholders can earn a maximum of twelve (12) rewards equivalent to 120 stamps for the entire promo duration.

- 4. Spend are considered "Qualified Transactions" under the following conditions:
 - a. Transactions made by the Primary Credit Cardholder; Supplementary Credit Cardholder/s' purchases will be qualified as part of the Primary Cardholder's accumulated spend.
 - b. Transactions made via straight or installment purchase transacted and posted within the Promo Period. Each installment transaction will be considered as one transaction amount. As such, succeeding monthly amortization from the same installment transaction will not be counted as separate transactions on Cardholder's account.
 - c. Cash Installment Plan, Balance Transfer and Balance Conversion, Split transactions (i.e. same merchant and same day), Business-related and casino transactions, Cancelled/Reversed and Fraudulent transactions are excluded from the Promo.
- 5. Cardholders who have Qualified Transactions will be identified and verified through HSBC's System. An SMS notification with the game site link and unique player code shall be sent out to Qualified Cardholders every cut-off date as stated below:

Note: Transactions must be posted. Posting is usually 3-5 days after transaction date.

- 6. Cardholders must follow the steps below to play the game and get the reward/s:
 - a. Click the game site link provided in the SMS notification
 - b. Enter the unique player code and the last 4 digits of his/her HSBC Credit Card.

Note that the unique player code and the last 4 digits of his/her HSBC Credit Card need to be keyed in every time cardholders visit the game site.

- c. Cardholders must tap each earned stamp in the game site. A PHP500 or PHP1,000 worth of eGCs will be revealed once he/she reaches the 10th stamp.
 - eGCs are randomly assigned to each Cardholder once stamps are earned. The Site will prompt the Cardholder to click "Move to My Rewards" to be able to view his/her Reward containing the unique eGC code. The eGC code is needed when redeeming his/her Reward at participating merchants' redemption outlets.
- 7. Cardholders must log in and use up their chances to earn stamps to get their rewards by **April 30**, **2020**. Unplayed stamps in the game site shall be forfeited after the said date.
- 8. Cardholders may use the eGC code/s at participating merchants from **November 18, 2019 until April 30, 2021**. Once redeemed, the eGC code/s may no longer be used to redeem another reward.

Upon redemption, cardholders must present the following requirements:

- a. The eGC code as reflected on the Cardholder's game site account
- b. The HSBC Credit Card used to make the Valid Transaction
- c. A valid photo-bearing government-issued Identification Card

The participating merchant partner will assist the Cardholder in his/her redemption.

- 9. Only the Qualified Cardholder is allowed to redeem the reward. Authorized representatives are disqualified from redeeming the Reward even if they present a written documentation from the Cardholder.
- 10. The cost of the reward/s shall be charged to the Cardholder's credit card account if redeemed through means which are later found to be invalid or if the Cardholder did not adhere to the Terms and Conditions of this Promo.
- 11. Rewards are not convertible to cash and are not subject to prize tax.
- 12. Qualified Cardholders authorize HSBC to disclose and publish their names, photos and other particulars as determined by HSBC to any person/s and in any mode or manner, as HSBC may deem appropriate. Qualified cardholders shall give their consent (written, electronic or recorded) on this matter at the time of redemption.
